ARTICLES OF INCORPORATION of PANTERA BONDED EXPRESS, INC.

The undersigned incorporator under these Articles of Incorporation, in order to form a corporation under the laws of Florida, hereby certify:

ARTICLE 1 - The name of the corporation is:

PANTERA BONDED EXPRESS, INC.

ARTICLE 2 - This corporation is to exist perpetually.

<u>ARTICLE 3</u> - The general purposes for which this corporation is organized is:

- (a) To engage in the business of transporting property, as well as persons, for hire by motor vehicle, aircraft, watercraft, and any other means of conveyance, as a common bonded carrier, common carrier or otherwise, and any other service in connection with such business, both at wholesale or retail, as principal or agent, and to acquire, own, operate, lease, and dispose of like businesses.


