Article I - Name and Address

Article VIII - Indemnification

Section 1 - Right to Indemnification. <u>Section 3 - Sayings Clause</u>. If this Article or any portion of it is invalidated on any ground by a court of competent jurisdiction, the corporation nevertheless indemnifies each person described in Section 1 of this Article to the fullest extent permitted by all portions of this Article that has not been invalidated and to the fullest extent permitted by law.

Article X - Duration

The duration of the corporation is perpetual, unless sooner liquidated or dissolved in accordance with law.
