



**ARTICLES OF INCORPORATION
OF
INDEPENDENT PHYSICIANS ASSOCIATION OF SARASOTA, P.A.**

The undersigned incorporation, for the purpose of forming a professional service corporation under the Florida Professional Service Corporation Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the professional formed hereby shall be Independent Physicians Association of Sarasota, P.A.

ARTICLE II - PURPOSE

The purpose of the Association shall be to serve as the general partner of a limited partnership of physicians who provide medical care services to patients in the Sarasota, Florida area, all of whom are licensed to provide physician services under Florida law.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be 921 S. Beneva Road, Sarasota, Florida 34232.

ARTICLE IV - CAPITAL STOCK

The number of shares of stock that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock, \$1.00 par value.


