ARTICLES OF INCORPORATION OF SAND DOLLAR FINANCIAL CORP.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be Sand Dollar Financial Corp.

Article II Principal Office and Mailing Address

<u>Section 2.1.</u> Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 8400 Baymeadows Way, Suite 3, Jacksonville, Florida 32256.
