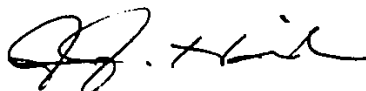

ARTICLE IV

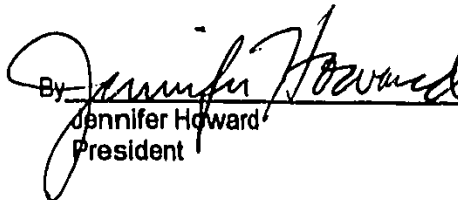
