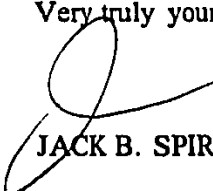

**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, Robert C. Stuhlmiller, subscriber to these Articles of Incorporation, a natural person, competent to contract, forms a corporation under the laws of the State of Florida; and further agrees to the following conditions of said corporation.

ARTICLE I - NAME

The name of this corporation is: DALABR, INC.

ARTICLE II - EXISTENCE

This corporation shall have perpetual existence commencing with the date of filing of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - AUTHORIZED STOCK

The corporation is authorized to issue 10 shares of common stock, having a par value of \$1.00 per share.

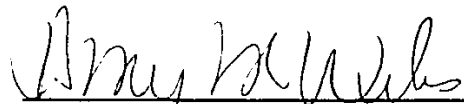

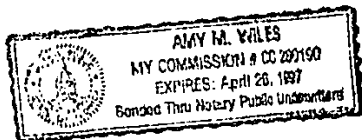
