ARTICLE I
Name and Principal Office

The name of this corporation is TELMORA ENTERPRISES, INC.
The principal place of business and mailing address of this corporation is 5898 NW 80th Avenue Road, Ocala, FL 34482.

Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III
Purpose

This corporation is organized for the purpose of transacting any and all lawful business, except that this corporation is not authorized to engage in the business of banking, insurance or engineering.

ARTICLE IV
Capital Stock
