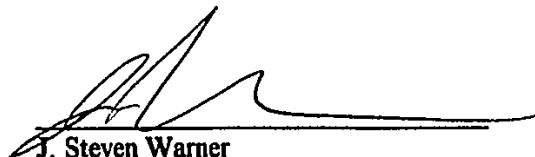

**ARTICLES OF INCORPORATION
OF
BOCA CARDS, INC.**

Pursuant to the Florida Business Corporation Act, these Articles of Incorporation provide that:

I. NAME

The name of this corporation shall be: **BOCA CARDS, INC.**

II. COMMENCEMENT OF EXISTENCE

1. Corporate existence shall commence as of April 14, 1997.

III. TERM OF EXISTENCE

1. This corporation is to exist perpetually.

IV. NATURE OF BUSINESS

1. This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

V. CAPITAL STOCK

1. The aggregate number of shares of stock which this corporation is authorized to issue is 1000 shares of common stock. The par value of the shares is \$0.01.

VI. REGISTERED AGENT AND OFFICE

1. The initial registered office of the corporation shall be located at 1367 Lyons Road, Coconut Creek, FL 33308. The initial registered agent for the corporation at that address shall be J. Steven Warner.

VII. PRINCIPAL OFFICE AND MAILING ADDRESS

1. The principal office and mailing address of the corporation is 5030 Champion Boulevard, #6-219, Boca Raton, Florida, 33496.

VIII. INCORPORATOR

1. The name and address of the incorporator to these Articles of Incorporation is: J. Steven Warner, 1367 Lyons Road, Coconut Creek, FL 33308.

IX. MANAGEMENT OF CORPORATE AFFAIRS

1. Any action required or permitted to be taken by the Board of Directors under any provision of law may be taken without a meeting, if all members of the Board shall individually or collectively consent in writing to such action. Such written consent or consents shall be filed with the minutes of the proceedings of the Board, and any such action by written consent shall

proceedings of the Board, and any such action by written consent shall have the same force and effect as if taken by unanimous vote of the Directors. Any certificate or other document filed under any provision of law which relates to action so taken shall state that the action was taken by unanimous written consent of the Board of Directors without a meeting, and that the Articles of Incorporation and the By-Laws of this corporation authorize the Directors to so act. Such a statement shall be prima facie evidence of such authority.

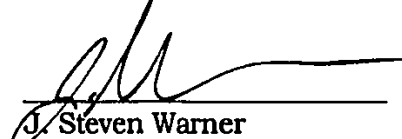
