Article I

Name

The name of the corporation is:

Article II

Duration

The corporation shall exist perpetually from the earliest date prior to the filing of these Articles of Incorporation allowed by law.

Article III

Purpose

Article XI


The directors of this corporation may take action by written consent as provided by law.

Article XII


Indemnification
