

ARTICLE OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, who is a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

The corporation may engage in the activities of creation and distribution of computer software under the laws and regulations of the State of Florida.






