ARTICLES OF INCORPORATION
OF
A & A CONSTRUCTION AND TILE, CORP

I, THE UNDERSIGNED, BEING OF LEGAL AGE AND A NATURAL PERSON,
DO HEREBY SUBSCRIBE TO, ACKNOWLEDGE AND FILE THE FOLLOWING
ARTICLES OF INCORPORATION FOR THE PURPOSE OF CREATING A
CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE A & A CONSTRUCTION
AND TILE, CORP, AND THE INITIAL ADDRESS OF THIS
CORPORATION SHALL BE: 4410 WEST 16 AVENUE, SUITE-5-305
HIALEAH, FLA. 33012.

ARTICLE II

THIS CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS
PERMITTED UNDER THE LAWS OF THE STATE OF FLORIDA AND UNDER
THE LAWS OF THE UNITED STATES OF AMERICA.

ARTICLE III

THE CAPITAL STOCK AUTHORIZED, THE PAR VALUE THEREOF, AND THE
CHARACTERISTICS OF SUCH STOCK SHALL BE AS FOLLOWS:
