The undersigned, hereby acting as incorporator for the purpose of forming a Professional Corporation for profit, by virtue of the provisions of Chapters 621 and 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is AYUB, SOKOL, MATZKOWITZ AND SENNABAUM, M.D.'S, P.A.

ARTICLE II

PRINCIPAL OFFICE

The principal office of this corporation is located at:
7651 Medical Drive, Hudson, FL 34667.

ARTICLE III

DURATION

This corporation shall have perpetual existence.

ARTICLE IV

PURPOSE

This corporation is organized for the following purposes:

1. To engage in every aspect of the practice of medicine and all its fields of specialization.
2. To engage and render the professional service involved

only through its officers, agents and employees who are in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the professional service as this corporation.

ARTICLE V

CAPITAL STOCK

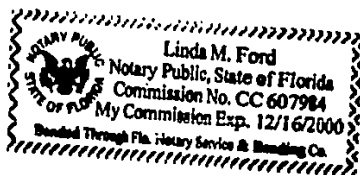
