ARTICLE I - NAME

The name of this corporation shall be CJS BUILDING SERVICES, INC.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business under Chapter 607, Florida Statues, as amended from time to time.

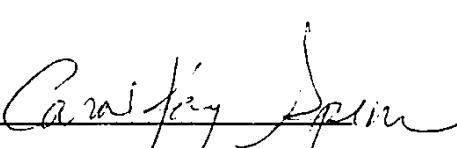

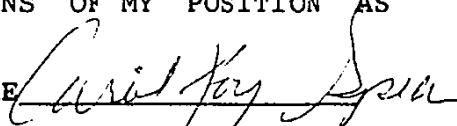
