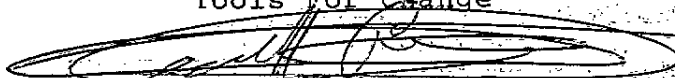

3. The shareholders are not required to vote on the amendment to the Articles of Incorporation.

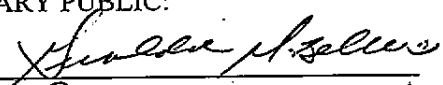
