**ARTICLES OF INCORPORATION  
OF  
ANGELA T. MILLER, P.A.**

The undersigned incorporator, for the purpose of forming a corporation in accordance with the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of this corporation shall be ANGELA T. MILLER, P.A.

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: Route 3, Box 184, Jasper, Florida 32052.

**ARTICLE III. PURPOSE**

The purpose for which the corporation is organized is to engage in the practice of law and provide mediation services and to transact all lawful business for which Corporations may be organized under the Florida Business Corporation Act. The services of this Corporation which consist of the practice of law and/or mediation services shall be carried out only through officers, employees and agents who are active members of the Florida or Georgia Bar Associations in good standing and licensed in Florida or Georgia to render the services of an attorney or mediator.

**ARTICLE IV. CAPITAL STOCK**

The aggregate number of shares of stock that the Corporation is authorized to issue is 100 shares having a par value of \$1.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to practice law and is an active member of the Florida or Georgia Bar Association in good standing.

**ARTICLE V. DURATION**

The Corporation shall have perpetual existence.

**ARTICLE VI. REGISTERED OFFICE AND AGENT**

#### ARTICLE VI. BOARD OF DIRECTORS

The Corporation shall be managed by a Board of Directors of at least 1 Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice law and is an active member of the Florida or Georgia Bar Association. The Directors shall be elected by the shareholders of the Corporation. The name and street address of each person who is to serve as a member of the initial Board of Directors is Angela T. Miller, 1117 Martin Drive, Tifton, GA 31794


#### ARTICLE VII. INCORPORATOR

The name and address of the Incorporator is Stephen D. Hurm.

#### ARTICLE VIII. AMENDMENT

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

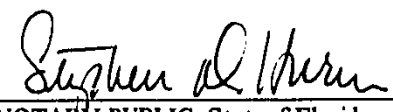

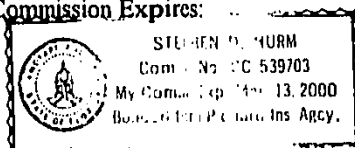
