Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, Insurance Markets of North Florida, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation, to be effective on Feb. 26, 2003.

**ARTICLE I
First Amendment**

The text of the only amendments to the Corporation's Articles of Incorporation are:

Article I. Name of the Articles of Incorporation of the Corporation is hereby amended, revised, and restated in its entirety to read as follows:

ARTICLE I NAME

The name of the corporation for profit is Lawyers Title Agency of North Florida, West Division, Inc.

Article V. Registered Office and Registered Agent of the Articles of Incorporation is hereby amended, revised and restated in its entirety to read as follows:

ARTICLE V. REGISTERED OFFICE AND REGISTERED AGENT.

**ARTICLE II
