ARTICLE I

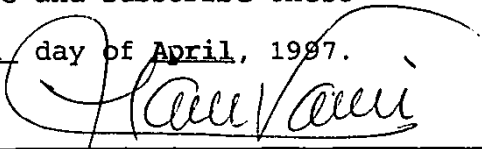

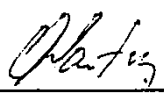
