

The name of the corporation is **SPEEDWAY AUTOMOTIVE, INC.** The principal address of the corporation is: 4897 N. University Drive, Lauderhill, Florida 33321.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


ARTICLE FIVE
