## ARTICLES OF INCORPORATION OF MEDLIFE MEDICAL PRODUCTS, INC.

THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### WITNESSETH:

#### ARTICLES I NAME AND ADDRESS
