ARTICLE III, PURPOSE

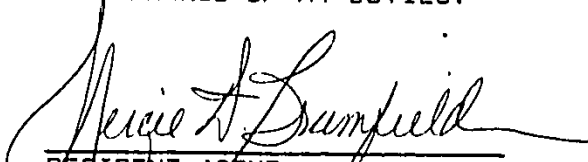
