

### ARTICLES OF INCORPORATION

OF

#### RJK SERVICES OF WEST FLORIDA, INC.

The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the Corporation is:

RJK SERVICES OF WEST FLORIDA, INC.

The address of the principal office of this Corporation shall be 3702 Wayward Avenue, Northport, Florida 34286, and the mailing address of the Corporation shall be the same.

ARTICLE 2. DURATION. The duration of the Corporation is perpetual.

- ARTICLE 3. PURPOSE. The general purpose for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- ARTICLE 4. CAPITAL STOCK. The aggregate number of shares which the Corporation is authorized to issue is One Thousand (1,000) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.
- ARTICLE 5. INITIAL REGISTERED OFFICE AND AGENT. The street address of the initial Registered Office of the Corporation is 1800- 2nd Street, Suite 808, Sarasota, FL 34236. The name of the initial Registered Agent of this Corporation at that address is: Christopher A. Likens, Esq.

ARTICLE 6. INITIAL BOARD OF DIRECTORS AND OFFICERS. The number of Directors constituting the initial Board of Directors is two. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one.
