

The Undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

## ARTICLE ONE

### NAME

The name and principal address of the corporation is NU-MAIN OF BROWARD, INC., at 125 North 46 Avenue, Hollywood, FL 33021.

# ARTICLE TWO

# DURATION

The term of existence of the corporation is perpetual.
