**ARTICLES OF INCORPORATION
OF

ARTICLE I. CORPORATE NAME

The name of this corporation is: JESUS IS THE LIGHT, INC., where the principal office is: P.O. Box 290416, Tampa, FL 33687

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.

The aggregate number of shares which this corporation shall have authority to issue is 2,500, shares of common stock having a NON Par value per share.

ARTICLE IV. TERM OF EXISTENCE.

This Corporation shall have perpetual existence commencing upon approval of the State.


