For the year 2002 the above-named corporation timely filed the Uniform Business Report with the following address:

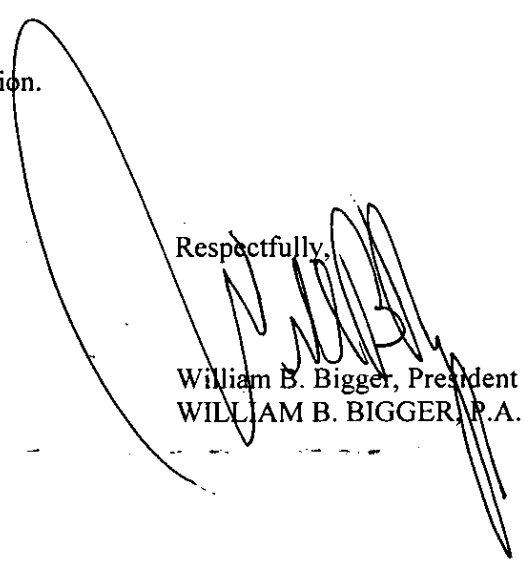
