

4. The registered agent of the corporation is **GENE CLUCKEY** and the registered address is **3880 40TH AVE. W., BRADENTON, FL 34205**


5. The initial Board of Directors shall have **1** member(s) whose name(s) and address(es) is/are as follows:

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.


