BEFORE ME, the undersigned authority, duly authorized to take acknowledgments and administer oaths, personally appeared CARLO JASBON who, after being by me first duly sworn, deposes and says:

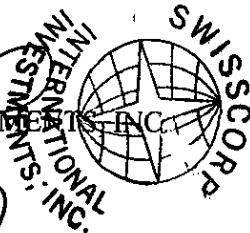
1. That I am the President of SWISSCORP INTERNATIONAL INVESTMENTS, INC., a Florida corporation (hereinafter "Corporation").
2. That on September 24, 1999, the Corporation was administratively dissolved by the Florida Department of State.
3. That the Corporation failed to file its 1999 Annual Report or pay the 1999 Annual Report filing fees within the time prescribed by Florida Statutes Chapter 607 because:
 - (a) the written notice and requirements for filing the Annual Report and pay the Annual Report fee to the Florida Department of State was never received by the Corporation; and,
 - (b) the written notice was never received by the Corporation or its Registered Agent that the Florida Department of State was commencing a procedure to administratively dissolve the Corporation.

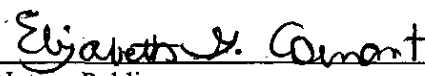
