I am hereby submitting to you my letter of resignation as it was submitted to the corporation on January 15, 1998. On January 22, 1998 Mr. Patrick M. Fultz, owner of 100% stock in the company, fired all employees. He has violated his lease and disappeared with all equipment. At this time he has disregarded company policy of severance pay and has basically left all employees without their paychecks. I am not certain of his intentions as all this was orchestrated without my knowledge and he has refused to give any information to any creditors. I do not believe tangible taxes were paid as of yet and am sending this notification to your office so that you will be aware if he attempts any activity. There is currently no officer to take my place and it is up to Mr. Fultz to determine what he plans for his company and to notify your office.

To Whom It May Concern,

I have given the many issues at FVI a lot of consideration. I previously resigned as President of the company because I did not want the personal liability with the problems over payroll taxes. After being assured there would be no more problems, I withdrew my resignation. Again today the wire was sent late. It has been corrected but not after once again being stressed at the situation.

I turned over my stock in the corporation 2 weeks before Christmas in order for payroll to be met. The day pay was to be made it was brought up that Tina Tice and I would need to take a cut in pay. I agreed to reduce my pay by over \$26,000.00 a year until the initial investment to the company was repaid with the understanding that all business responsibilities would be taken over and I would only handle the adult issues which are my strength. Because a portion of the responsibilities would be taken off of my shoulders and the workload lessened, I agreed to the lesser amount of pay. Now I find that this was not true.

I will not go into the issues of having to decipher who is being told the truth and who is not but it has only added to the weight of responsibility. If I am paid the same payscale as someone who does not have my responsibilities or the financial risks for payroll then I see no reason to take those responsibilities. I can make a better income elsewhere and have stayed at FVI more due to friendship and my concern for the employees at the business, but at this point I see even that abused.

I will remain at FVI to see that it gets operational but I see very little hope that my stock will be returned. I am resigning as President of Fantasy Visions, Inc. and will be removing my name from all accounts as soon as a replacement is established. I will remain as an "employee only" of the company at the pay and benefit scale I am currently under.

It has been more than obvious that after making myself clear to our investor I was not interested in a personal physical relationship I have had numerous conflicts to deal with and am no longer willing to subject myself to this.

My resignation as President will be effective January 29, 1998 before the next tax deposit is due.
