The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I  
NAME**

The initial registered agent of the corporation is Donerl B. Mann, and the initial registered office of the corporation is 9930 NE 7th Court, Branford, Florida 32008.




