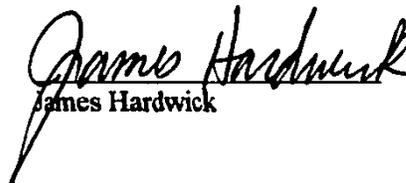
ARTICLE IX-INDEMNIFICATION
