The board of Directors may from time to time move the principal office to any other address in the state of Florida.


ARTICLE VII, BOARD OF DIRECTORS

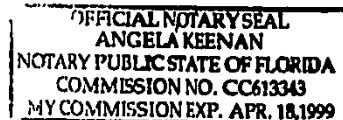
