#### ARTICLE I NAME

The name of this corporation is DANCING LIGHT PHOTOGRAPHIC, INC.

### ARTICLE II TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of filing of these Articles of Incorporation by the Department of State.

#### ARTICLE III CORPORATE PURPOSE

The corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV AUTHORIZED SHARES

The Aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock with a \$1.00 par value per share. It is intended that stock issued by this corporation shall be in accordance with Sect 1294 of the Internal Revenue Code of 1986 as amended.
