# ARTICLES OF INCORPORATION OF DR. DARYANANI, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Acker hereby adopts the following Articles of Incorporation.

### ARTICLE I

# NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION
