ARTICLE I - NAME

The name of this corporation is **BIJO, INC.** The principal office and mailing address of this corporation is: **10441 N.W. 12th Place, Plantation, Florida 33322.**

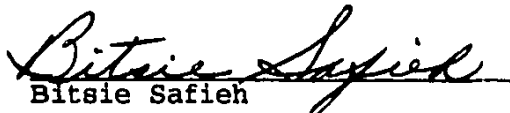

ARTICLE X - AMENDMENT

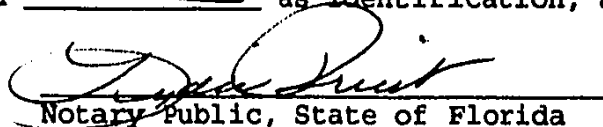
