**ARTICLES OF INCORPORATION
OF
EUROTRANSPORT SERVICES, INC.**

(a Florida corporation)

In compliance with Chapter 607 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purposes of organizing a business corporation.

ARTICLE I

NAME

The name of the corporation (the "Corporation") is:

EUROTRANSPORT SERVICES, INC.

ARTICLE II

PURPOSE

The purpose of the Corporation shall be to conduct any lawful activity.

ARTICLE III

EFFECTIVE DATE

The effective date of the filing of this Articles of Incorporation shall be 21 April 1997.

ARTICLE IV

PRINCIPAL ADDRESS

ARTICLE V

CAPITAL STOCK
