The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

**ARTICLE I**

The name of this Corporation shall be DBL PRODUCTS, INC.

**ARTICLE II**

**ARTICLE III**

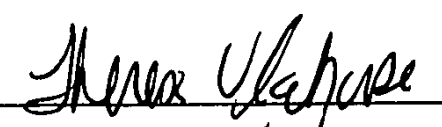

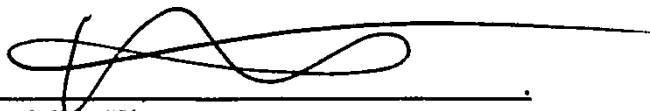
