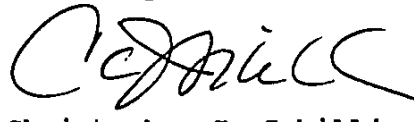

Be it further resolved that this amendment shall be effective when approved by the Department of State of the State of Florida.

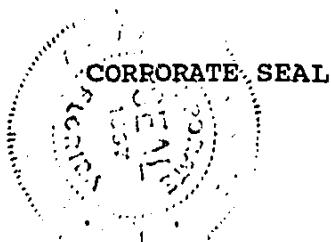

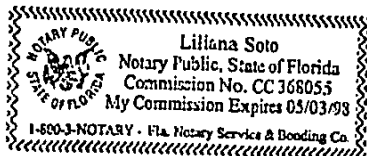
