# ESFECTIVE DATE

# <u> Article I - Name</u>

The name of this corporation is BRIGHTSIDE INSURANCE, INC.

# Article II - Duration

This corporation shall exist perpetually commencing on April 21, 1997.

# Article III - Purpose

This corporation is organized:

- 1. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.
- 2. To engage in any activity or business permitted under the laws of the United States and of this State, as the same may be from time to time amended.

# Article IV - Capital Stock
