ARTICLES OF INCORPORATION

The undersigned incorporator, MICHAEL P. WILLIAMS, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is PERDIDO PASS ENTERPRISES, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 1020 Oak View Drive, Pensacola, Florida 32506.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.
