The undersigned incorporation to these Articles of
Incorporation hereby forms a corporation under the laws of
the State of Florida as follows:

ARTICLE I - NAME

1 COMMUNICATIONS
The name of the corporation is TELECOM, INC.

ARTICLE II - TERM OF EXISTENCE

The date when corporate existence shall commence shall
be the date of the filing of these Articles of Incorporation
by the Office of the Secretary of State of the State of
Florida and the corporation shall have perpetual existence
thereafter.

ARTICLE III - PURPOSES

This corporation is organized to include the transaction
of any and all lawful business for which corporations may be
incorporated under the laws of the United States and the
State of Florida as presently enacted and as may be amended
from time to time.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred
thousand shares of one dollar (\$1.00) per value common stock
which shall all be of one class of common shares.

ARTICLE V - PREEMPTIVE RIGHTS

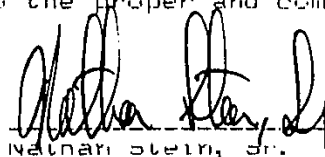
