ARTICLES OF INCORPORATION

OF

DELEO ENTERTAINMENT, INC.



FIRST. The name of this corporation is DELEO ENTERTAINMENT, INC.

SECOND. The address of the initial principal office of the corporation is 2500 N. Military Trail, #235, Boca Raton, Fl. 33431.

THIRD. The address of the registered office in the State of Florida is 2500 N. Military Trail, #235, Boca Raton, FL 33431. The Registered Agent in charge there of is Bruce DeLuca.

FOURTH. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

FIFTH. The corporation shall be authorized to issue 100 Shares of stock at \$1.00 Par Value.

SIXTH. The name and address of the incorporator is as follows: Incorporating Services, Ltd. - 15 East North Street, Dover, DE 19901
