ARTICLES OF INCORPORATION FOR LaserAce, Inc.

The undersigned incorporators, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be:

LaserAce, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 837 N.E. 20th Avenue, Ft. Lauderdale, Florida 33304.

ARTICLE III - SHARES

The number of shares of stock that the corporation is authorized to have outstanding at any one time is: Thirty Thousand (30,000) shares, having a par value of One Dollar (\$1.00).

The preferences, qualifications, limitations, restrictions and the special or relative rights in respect to the shares of each class of stock are as follows: There shall be only one (1) class of stock - all shares shall be common, entitling holders to one vote for each issued share, except as otherwise provided by law.
