# **ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation shall be AA NATIONAL TRANSMISSION SERVICE, NO. 4., INC.

#### **ARTICLE II**

The corporation shall have perpetual existence, unless sooner dissolved according to law.

#### ARTICLE III

The general nature of the business or businesses to be transacted by this corporation shall be: to buy, sell, trade and otherwise deal in any and all manner of automobile repair.
