ARTICLES OF INCORPORATION
OF
SABINE DAY CARE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of corporation:

ARTICLE I NAME AND ADDRESS

The name of the Corporation is : SABINE DAY CARE, INC. The principal office is: 625 NE 129TH STREET, Miami, Florida 33161

ARTICLE II -DURATION

The duration of the Corporation is perpetual.

ARTICLE III- PURPOSE

The general purposes for which the Corporation is Organized are the following:

A. To engage in and transact any lawful business for which Corporations may be Incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

C. To operate a day care facility and all matters related thereto.

ARTICLE IV - SHARES

The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE V-INITIAL REGISTERED OFFICE AND AGENT

The street address of the Initial Registered Office of the Corporation is 625 NE 129th Street Miami, Florida 33161 and the name of its Initial agent at that address is KENIDD FEVRY.

ARTICLE VI- INITIAL BOARD OF DIRECTORS

The number of directors constituting the Initial Board of Directors is 1. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. The name and address of each initial Director of the corporation is as follows:




