ARTICLES OF INCORPORATION

OF

SHINNY HOUSE, INC.,

A FLORIDA CORPORATION FOR PROFIT

The undersigned, acting as Incorporator of Shinny House, Inc. a Florida Corporation for Profit, (the "Corporation") under the Florida Corporation Act, of the Florida Statutes hereby adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

NAME

The name of the Corporation is Shinny House, Inc. and the street address for the initial principal office of the Corporation is 155 Lakeview Drive Building 303 Apartment 103, Sunrise, Plorida 33326.

ARTICLE II

PURPOSE

2.1 The purpose of the Corporation is to provide cleaning or janitorial services for residential (single) family homes. The Corporation is intended to be operated exclusively for those purposes and as such has applied for an Employer Identification Number from the U.S. Internal Revenue Service, in Tailahassee, Florida. The Corporation is committed to provide a reliable, and efficient service, such as complete house cleaning, which promotes the health and well-being of its residents.

- 2.2 The Corporation shall possess and exercise all the powers and privileges granted by the Florida Statutes as they now exist or as they be hereafter amended, or by any other law of Florida applicable in any manner; limited only by the restrictions set forth in these Articles of Incorporation.
- 2.3 Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not conduct or carry on any other activities not permitted to be conducted or carried on by (i) an organization under the U.S. Internal Revenue Codes and the Treasury Regulations promulgated thereunder as they now exist or as they may be hereafter amended, or (ii) by the laws of the State of Plorida as they now exist or as they may be hereafter amended.

ARTICLE III

QUALIFICATION OF MEMBERS

The members of this Corporation shall be the duly elected members with the rights, qualification and manner of admission to such capacities as provided in these Articles of Incorporation.

ARTICLE 1V

TERM OF EXISTENCE

This Corporation is intended to have perpetual existence.

ARTICLE V

BOARD OF DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the affairs of the Corporation shall be managed under the direction of, a Board of Directors, except as may be otherwise provided in these Articles of Incorporation or as may be

otherwise required by any of the provisions of the Florida Statutes as it now exists or as it may be hereafter amended. The number of Directors shall consist of at least three (3) persons, holding the following offices: President, Vice President, and Secretary/Treasurer, respectively. The Board of Directors shall be elected every three (3) years.

ARTICLE VI

SHARES

Every one of the Directors of the Corporation shall invest in the Corporation one (1) third or 33.33% of its shares.

ARTICLE VII

DISSOLUTION

In the event that the Corporation shall be dissolved, it is agreed to divide equally all the profits, less any outstanding balance of the incurred debts, in three (3) thirds or 33.33%. This portion will be given to each Director of the Corporation, unless it is specify in this Articles of Incorporation otherwise.

ARTICLE VIII
