The undersigned acting as subscriber(s) of a corporation under the Florida Corporation Law, adopt the following of Incorporation for such Corporation.

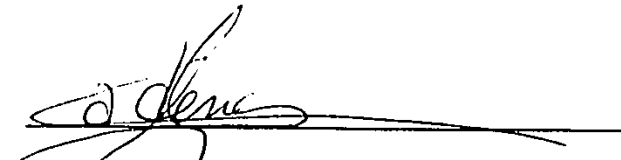
