WE, the undersigned hereby associated ourselves together for the purpose of becoming a corporation under and by virtue of the laws of the State of Florida, by and under the provisions of the statutes of the Sate of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.
