**ARTICLES OF INCORPORATION
OF
WPBF LICENSE, INC.**

The undersigned, acting as incorporator of WPBF LICENSE, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

ARTICLE III. COMMENCEMENT OF EXISTENCE


ARTICLE IX. BYLAWS
