ARTICLES OF INCORPORATION

SOUTH BEACH CAFE-FLORIDA, INC.

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is / SOUTH BEACH CAFE-FLORIDA, INC., and its principal office or mailing address is 5125 Willow Leaf Drive, Sarasota, Florida 34241.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.
