4. The number of shares which the corporation shall have authority to issue shall be:

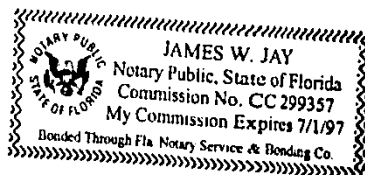
1000 shares of common stock having a
