The name of this Corporation is JUVENILE/ADULT WORK SERVICES, INC., and its address is 20860 SAN SIMEON WAY Unit # 109, Miami, Florida 33179.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation shall indemnify any Officer of Director, or any former Officer or Director, to the full extent permitted by law.

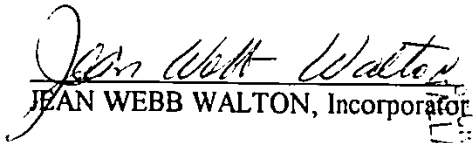
